

## **Notice of Benefits and Services Available from the HIV/AIDS Services Administration (HASA)**

Please be advised that if you have at any time been diagnosed with clinical/symptomatic HIV illness as defined by the New York State AIDS Institute or with AIDS as defined by the Federal Centers of Disease Control and Prevention, you may be eligible for admission into HASA. HASA provides specialized services to individuals and families living with AIDS or advanced HIV illness.

HASA participants may be eligible for the following benefits and services:

- Medically appropriate transitional and permanent housing
- Housing subsidies, including, but not limited to, enhanced rental assistance
- Medical and other health-related services
- Home care
- Homemaking service
- Supplemental Nutrition Assistance Program (SNAP)
- Transportation and nutrition allowances
- Financial benefits
- Case management
- Information and program referrals on child care options and custody planning, including the availability of standby guardianship
- Referral to legal assistance programs
- Referral to drug treatment programs
- Referral to voluntary employment and job training programs
